# ANGLICAN CHURCH PROPERTY TRUST DIOCESE OF SYDNEY AMENDMENT ORDINANCE 1989

#### No 29, 1989

AN ORDINANCE to amend the Anglican Church Property Trust Diocese of Sydney Ordinance 1965.

WHEREAS it is expedient to amend the said Ordinance.

NOW the Synod of the Diocese of Sydney HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows.

## Citation

- 1. (1) This Ordinance may be cited as "Anglican Church Property Trust Diocese of Sydney Ordinance Amendment Ordinance 1989".
- (2) The Anglican Church Property Trust Diocese of Sydney Ordinance 1965-1982 is hereinafter referred to as the "Principal Ordinance".

## Minor Amendments

- 2. ¿Clause 2 of the Principal Ordinance is amended -
  - (a) by omitting the words "A Board" from item (a) and by inserting instead "board":
  - (b) by omitting the word "Church" from item (b) and by binserting instead "church";
  - (c) by omitting the word "Diocesan" from item (c) and by inserting instead
    "diocesan"; and
  - (d) by omitting item (e).
- 3. Clause 3 of the Principal Ordinance is amended -
  - (a) by omitting the words "Anglican Church Property Trust Diocese of Sydney hereinafter called";
  - (b) by omitting the words "Church of England in" and by inserting instead "Anglican Church of"; and
  - (c) by omitting the proviso.
- 4. Clause 4B of the Principal Ordinance is amended
  - (a) by omitting the figures "70" and inserting "72°; and a
  - (b) by adding the following new sentence at the end of the clause:
    - "A person of or above the age of \$72 years is not eligible to be elected to or to act as a member of the Corporate Trustee."
- 5. Clause 4E of the Principal Ordinance is amended -
  - (a) by omitting the word "Any" and by inserting instead "(1) Subject to subclauses (2) to (4), any";

- (b) by omitting the words "except that:-" and by inserting instead the matter ".";
- (c) by omitting from item (2) (b) the figures "70" and by inserting instead "72";
- (d) by omitting from item (3) the word "paragraph (2)" and by inserting instead "subclause (3)"; and
- (e) by omitting the matter "(1)", "(2)", "(3)" and "(4)" and by inserting instead "(2)", "(3)", "(4)" and "(5)" respectively.

## Execution of Documents

- 6. The Principal Ordinance is amended by the insertion of "(1)" before the first word of clause 8 and by the insertion of the following at the end of clause
  - "(2) Any deed or instrument, executed or signed, and any other act, matter, or thing done by any two members of the Corporate Trustee in pursuance of a resolution of the Corporate Trustee shall be as effectual as if the same had been executed, signed, or done by all the members of the Corporate Trustee."

#### Minor Amendment

7. Clause 10 of the Principal Ordinance is amended by omitting the matter "(i)", "(ii)" and "(iii)" and "by inserting instead "(1)", "(2)" and "(3)" respectively.

#### Power of Attorney

- 8. The Principal Ordinance is amended by the insertion of "(1)" before the first word of clause 13 and by the insertion of the following at the end of clause 13 -
  - "(2) The Corporate Trustee by power of attorney, may appoint any corporation firm, person or body of persons to be the attorney or attorneys of the Corporate Trustee for such purposes and with such powers, authorities and discretion (not exceeding those which the Corporate Trustee may have) and for such period and subject to such conditions as the Corporate Trustee May think fit."

### Minor Amendments

- 9. Clause 16 of the Principal Ordinance is amended by omitting the word "Board" and by inserting instead "board".
- 10. Clause 17 of the Principal Ordinance is amended by omitting the matter "(i)" "(ii)", "(iii)" and "(iv)" and by inserting instead "(a)", "(b)", "(c)" and "(d)" respectively.

## ANGLICAN CHURCH PROPERTY TRUST DIOCESE OF SYDNEY AMENDMENT ORDINANCE 1989

- 11. The preamble of the Principal Ordinance is amended -
  - (a) by omitting from the first recital the words "Church of England" and by inserting instead "Anglican Church of Australia"; and
  - (b) by omitting from the fifth recital the words "Church of England Constitutions Act of" and inserting instead "Anglican Church of Australia Constitutions Act".
