

Connect09 Amendment Ordinance 2007

No 38, 2007

Long Title

An Ordinance to establish a committee to manage the evangelistic outreach campaign known as Connect09 and for related matters.

The Standing Committee of the Synod of the Diocese of Sydney Ordains as follows.

1. Name

This Ordinance is the Connect09 Amendment Ordinance 2007.

2. Amendments to the Connect 09 (Funding) Ordinance 2007

The Connect 09 (Funding) Ordinance 2007 is amended as follows –

- (a) delete each reference to the matter “Connect 09” and insert instead “Connect09”, and
- (b) delete each reference to the matter “(Funding)”, and
- (c) insert the words “and management” after the word “funding” in the long title, and
- (d) insert a new recital D in the Preamble as follows –

“D. It is also expedient to establish a committee to manage Connect09.”, and
- (e) insert a new clause 3A as follows –

“3A. Management of Connect09

(1) The Archbishop may appoint a group of persons under his chairmanship (the ‘management committee’) to manage the implementation of Connect09. For this purpose the management committee –

- (a) is to prepare a strategic plan for the implementation of Connect09 for the period 2008-2010 and revise the plan from time to time, and
- (b) is to identify in the strategic plan the key criteria by which progress in implementing the strategic plan can be assessed, and
- (c) is to provide a copy of the strategic plan and a copy of any revised plan to the Standing Committee as soon as practicable, and
- (d) is to prepare updated financial forecasts for Connect09 every 6 months, and
- (e) is to report to each meeting of the Standing Committee a summary of progress in implementing Connect09 assessed against the key criteria identified under paragraph (b) and against current financial data for Connect09.

(2) The management committee may, by resolution, approve the payment of any expense incurred or to be incurred for the purpose of implementing Connect09 subject to such limits and other conditions as the Standing Committee may from time to time determine by resolution. Any expense which the management committee is unable or unwilling to approve under this subclause may be approved by resolution of the Standing Committee.

(3) The quorum for meetings of the management committee is 3. The management committee may otherwise determine the manner in which its business is conducted.

(4) The Archbishop may, in his absolute discretion, remove any person from the management committee.”

3. Initial form of strategic plan

The management committee established by this Ordinance is to provide the Standing Committee with a copy of the initial form of the strategic plan for the purposes of clause 3A(1)(c) by 29 February 2008.
