AN ORDINANCE to amend the General Assessment Authorisation Ordinance, 1959, as amended to provide for variations in allowable deductions and matters incidental thereto.

WHEREAS Synod has provided the basis for the assessment of parishes provisional parishes and provisional districts by the General Assessment Authorisation Ordinance 1959-1969 and therein provided for certain "allowable deductions" AND WHEREAS it is desirable to provide that gifts for the support of specific candidates for training for the ordained ministry be allowable deductions provided they are paid through the churchwardens and the diocesan office NOW the Synod of the Diocese of Sydney HEREBY ORDAINS DIRECTS DECLARES AND RULES as follows:—

1. This Ordinance may be cited as the "General Assessment Authorisation Amendment Ordinance 1970".
2. The General Assessment Authorisation Ordinance 1959-1969 is in this Ordinance referred to as the "Principal Ordinance".
3. The Principal Ordinance as amended by this Ordinance may be cited as the "General Assessment Authorisation Ordinance 1959-1970".
4. Sub-clause (2) of Clause 14 of the Principal Ordinance is amended by the addition of the following paragraph:
"(n) Any donations or contributions received towards the support of any specific candidate in training for the ordained ministry of the Church of England in Australia provided they are paid through the churchwardens and the Sydney Diocesan office."
