

*General Synod—Amended Rules for the Formation of New
Dioceses.*

No. 10, 1946.

AN ORDINANCE to accept and to apply the provisions of Determination I of 1945 intituled "A Determination to amend Section V of Determination I of 13th October, 1876, amended by Determination IV of 3rd September, 1900" in the order and good government of the Church of England within the Diocese of Sydney.

WHEREAS Determination No. I 1945 intituled "A Determination to amend Section V of Determination I of 13th October, 1876, amended by Determination IV of 3rd September, 1900" a copy whereof is contained in the Schedule hereto has been made by General Synod.

AND WHEREAS under Article No. 3 in the Schedule to the Church of England Constitutions Act Amendment Act of 1902 the Diocese may make ordinances upon and in respect of all matters and things concerning the order and good government of the Church of England and the regulation of its affairs within the Diocese.

AND WHEREAS by an Ordinance assented to on 21st June, 1876, regulating the method of accepting Determinations of General Synod it was provided that the mode of acceptance of such Determinations should be by Ordinance.

AND WHEREAS it is expedient to accept and to apply the provisions of the said Determination No. I 1945 as hereinafter expressed.

The Synod of the Diocese of Sydney in pursuance of its powers under the said Act hereby ordains and rules as follows:—

The said Determination No. I 1945 is and the provisions therein contained are accepted and shall be applied in the order and good government of the Church of England within this Diocese in like manner as if the same were herein and hereby expressly ordained and ruled.

SCHEDULE.

GENERAL SYNOD OF THE DIOCESES IN AUSTRALIA AND
TASMANIA.

DETERMINATION 1. SESSION 1945.

A DETERMINATION to amend Section V of Determination
I of 13th October, 1876, amended by Determina-
tion IV of 3rd September, 1900:

That the whole clause be repealed and the following clause
be inserted in lieu thereof:

"That before any new Diocese (except a Missionary
Diocese) be formed

- (a) The minimum number of clergy to be incorporated
in such Diocese shall be thirty.
- (b) In the opinion of the Metropolitan (or of the Primate
if there is no Metropolitan) adequate financial provision
shall have been made for the maintenance of the
Diocese, for the stipend and travelling expenses of the
Bishop, and for a suitable episcopal residence.
