

*General Synod — Board of Assessors
(Appellate Tribunal) Canon 1962 Adopting Ordinance 1974*

No. 34, 1974

AN ORDINANCE to adopt a certain canon of the Church of England in Australia entitled "Board of Assessors (Appellate Tribunal) Canon 1962".

5 WHEREAS a certain canon entitled "Board of Assessors (Appellate Tribunal) Canon 1962" (No. 5, 1962) was passed by the General Synod of the Church of England in Australia during the session of the said Synod held in 1962 AND WHEREAS a copy of the said Canon is contained in the Schedule hereto AND WHEREAS it is expedient
10 that the said Canon be adopted by the Synod of this Diocese NOW the Synod of the Diocese of Sydney HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:—

1. The said Canon is hereby adopted and shall so far as the same is applicable be applied to the order and good government of the
15 Church in this Diocese.

2. This Ordinance may be cited as "General Synod — Board of Assessors (Appellate Tribunal) Canon 1962 Adopting Ordinance 1974".

SCHEDULE

20 A CANON Providing for the Appointment of a Board of Assessors (Appellate Tribunal)

The General Synod prescribes as follows:—

1. A Board of Assessors for the purpose of section 58 of the Constitution shall be elected at each session of Synod.
- 25 2. The Board shall consist of seven priests.
3. Any priest may be nominated for election to the said Board by two members of Synod.
4. If more than seven priests be so nominated a ballot shall be taken by a vote of the Houses of Synod voting together and the provisions of the rules for the conduct of elections ordered
30 to be made by Synod shall apply thereto.
5. In any case where the Appellate Tribunal desires the opinion of the Board such opinion shall be given in writing and if the Board be not unanimous the members may furnish a majority and a minority opinion or individual opinions as they
35 see fit to do.
6. A vacancy on the Board shall occur if a member die, resign, be declared by any competent court incapable of managing his affairs, cease to reside permanently in Australia or cease
40 to hold a licence from a Diocesan Bishop. And if a vacancy should occur between sessions of Synod it may be filled by election at a meeting of the Standing Committee
- 7 This Canon may be cited as the "Board of Assessors (Appellate Tribunal) Canon, 1962".
