

GENERAL SYNOD — CONSTITUTION ALTERATION (DEACONS AND THE HOUSES OF SYNOD) CANON AND BILL 1985 ASSENTING ORDINANCE 1986

No. 35, 1986

AN ORDINANCE to assent to General Synod Canon No. 22, 1985 and Bill No. 2, 1985.

WHEREAS:

5 A. The Constitution Alteration (Deacons and the Houses of Synod) Canon 1985 and the Constitution Alteration (Deacons and the Houses of Synod) Bill 1985 (hereinafter called "the Canon and Bill") were made by the General Synod of the Anglican Church of Australia in 1985.

10 B. Copies of the Canon and Bill are contained in the Schedules hereto.

C. It is expedient that the Canon and Bill be assented to by the Synod of this Diocese.

NOW the Synod of the Diocese of Sydney HEREBY ORDAINS
15 DECLARES DIRECTS AND RULES as follows:

Assent to Canon and Bill

1. The Synod hereby assents to the Canon and Bill.

Citation

20 2. This Ordinance may be cited as the "General Synod — Constitution Alteration (Deacons and the Houses of Synod) Canon and Bill 1985 Assenting Ordinance 1986".

FIRST SCHEDULE

A Canon to alter the Constitution in relation to Deacons and the Houses of Synod.

25 The General Synod prescribes as follows:

1. The Constitution is altered to the extent provided in the Schedule to this Canon.

2. Section 30 is altered by the insertion after paragraph (d) of the following additional paragraph:

30 (e) This section shall not apply and shall be deemed never to have applied to a canon to alter this Constitution.

3. The amendments to the Constitution that are made by this Canon shall come into force on a date to be appointed and declared by the Primate who shall follow, mutatis mutandis, the notification procedure prescribed by Rule XX.

35 4. This Canon may be cited as "Constitution Alteration (Deacons and the Houses of Synod) Canon 1985".


The General Synod prescribes as follows:




