*Glebe Administration Ordinance 1930 Further Amendment

AN ORDINANCE to further amend the Glebe Administration Ordinance 1930-1971.

WHEREAS it is expedient that Glebe Administration Board be appointed the trustee of certain land adjoining St. Andrew's Cathedral such land being as to part, the land defined as "Lot 1" in the St. Andrew's Cathedral Site Ordinance 1972 and, as to the balance, the land defined as the "acquired land" in the St. Andrew's Cathedral Site Development Ordinance 1970 NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:—

1. (1) The Glebe Administration Ordinance 1930-1971 as amended by the Glebe Administration Ordinance 1930 Amendment Ordinance 1972 is hereinafter called the "Principal Ordinance".

(2) Clause 3 of the Glebe Administration Ordinance 1930 Amendment Ordinance 1972 is hereby repealed.

(3) This Ordinance may be cited as "Glebe Administration Ordinance 1930 Further Amendment Ordinance 1972".

(4) The Principal Ordinance as amended by this Ordinance may be cited as "Glebe Administration Ordinance 1930-1972".

2. The Principal Ordinance is hereby amended by:—

(a) the insertion of the following subclause after subclause (2) of clause 13.—

"(3) The Board shall exercise and perform the powers, authorities duties and functions conferred or imposed upon it by or pursuant to this Ordinance in so far as the same relate to the land adjoining St. Andrew's Cathedral (such land being, as to part, the land defined as 'Lot 1' in the St. Andrew's Cathedral Site Ordinance 1972 and, as to the balance, the land defined as the 'acquired land' in the St. Andrew's Cathedral Site Development Ordinance 1970) and any development on or under the said land and the financing thereof only to the extent authorised by and subject to the directions of the Standing Committee given from time to time by resolution thereof."

(b) by the insertion of the following paragraph after paragraph (b) of subclause (2) of clause 13:—

"(ba) to draw, make, accept, endorse, discount, execute

and issue promissory notes, bills of exchange, bills of lading and other negotiable or transferable instruments,"; and

- (c) the insertion of the words "and the said land adjoining St. Andrew's Cathedral" after the words "Bishophorpe Estate" in clause 14.

AN ORDINANCE to further amend the Glebe Administration Ordinance 1930-1971.

WHEREAS it is expedient that Glebe Administration Board be appointed the trustee of certain land adjoining St. Andrew's Cathedral such land being as to part, the land defined as "Lot 1" in the St. Andrew's Cathedral Site Ordinance 1972 and, as to the balance, the land defined as the "acquired land" in the St. Andrew's Cathedral Site Development Ordinance 1970 NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:—

1. (1) The Glebe Administration Ordinance 1930-1971 as amended by the Glebe Administration Ordinance 1930 Amendment Ordinance 1972 is hereinafter called the "Principal Ordinance".

(2) Clause 3 of the Glebe Administration Ordinance 1930 Amendment Ordinance 1972 is hereby repealed.

(3) This Ordinance may be cited as "Glebe Administration Ordinance 1930 Further Amendment Ordinance 1972".

(4) The Principal Ordinance as amended by this Ordinance may be cited as "Glebe Administration Ordinance 1930-1972".

2. The Principal Ordinance is hereby amended by:—

(a) the insertion of the following subclause after subclause (2) of clause 13.—

"(3) The Board shall exercise and perform the powers, authorities duties and functions conferred or imposed upon it by or pursuant to this Ordinance in so far as the same relate to the land adjoining St. Andrew's Cathedral (such land being, as to part, the land defined as 'Lot 1' in the St. Andrew's Cathedral Site Ordinance 1972 and, as to the balance, the land defined as the 'acquired land' in the St. Andrew's Cathedral Site Development Ordinance 1970) and any development on or under the said land and the financing thereof only to the extent authorised by and subject to the directions of the Standing Committee given from time to time by resolution thereof."

(b) by the insertion of the following paragraph after paragraph (b) of subclause (2) of clause 13:—

"(ba) to draw, make, accept, endorse, discount, execute

and

- (c) the insertion of the words "and the said land adjoining St. Andrew's Cathedral" after the words "Bishopthorpe Estate" in clause 14.
