*Hartley Cum Mount Victoria Vesting and Land Sale  
Ordinance 1962 Amending Ordinance 1966*

No. 8, 1966.

AN ORDINANCE to vary the application of the income arising from the investment of the proceeds of sale of certain land at Hartley in the Parish of Wallerawang.

WHEREAS since the passing of the Hartley cum Mount Victoria Vesting and Land Sale Ordinance 1962 the parish of Hartley cum Mount Victoria has been revoked and AND WHEREAS the land described in the schedule hereto is now part of the parish of Wallerawang AND WHEREAS the income arising from the investment of the proceeds of the sale of the said land has been applied towards the general parochial purposes in the former parish of Hartley cum Mount Victoria AND WHEREAS it is now expedient that such income should be applied towards the upkeep and maintenance of the Church of St. John the Evangelist at Hartley NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod HEREBY ORDAINS AND DIRECTS as follows:

1. By reason of circumstances which have arisen subsequent to the creation of the Trusts upon which the land described in the Schedule hereto is held it is inexpedient to carry out and observe the same and it is expedient that the said trusts be varied in the manner hereinafter provided.

2. Clause 4 of the original ordinance is amended by the deletion of the words "St. Peter's Church Mount Victoria" and by the substitution therefor of the words "St. John the Evangelist Church Hartley" and also by the deletion of the words "general parochial purposes in such parish" and by the substitution therefor of the words "the upkeep and maintenance of the fabric of the said Church."

3. This Ordinance may be cited as "Hartley cum Mount Victoria Vesting and Land Sale Ordinance 1962 Amending Ordinance 1966."

SCHEDULE

All that piece or parcel of land situated near Hartley in the Parish of Hartley County of Cook containing 5 acres 3 roods 10 perches or thereabouts having a frontage to the Great Western Highway (formerly Bathurst Road) and being the whole of the land comprised in Certificate of Title Registered Volume CCXX Folio 48.
