*** New Module Release ***

Shortly, every parish in the Diocese will receive a 'supplement' to Module 1 of the Parish Risk Management Program titled, '**Specific Parish Incident Notification Procedures**'. The module describes the process for how your parish will inform the Diocese of certain '**notifiable incidents**' that occur, which are also reportable to **WorkCover NSW**.

A **dedicated number** has been established to assist in the reporting process – the number is **1300 302 442**.

The process will provide **valuable and necessary assistance** to the parish in the event of an incident when stress levels may be high. Through this process the Diocese will be able to marshal the necessary resources to guide the parish through the incident.

On receipt of the new module:

1. **Read** through it thoroughly;
2. **Discuss** it at your next Parish Council meeting;
3. **Communicate** the process and the 1300 number to all ministry teams, tenants and members of the congregation;
4. **Place** the A4 Notification 'wall chart' that will be received with the module **in a central location**.

Electing new Churchwardens?

For those parishes planning to **elect new churchwardens**, please ensure there is a '**handover**' in regard to your parish's risk management program by:

1. providing **access to the risk management binder**
2. providing a **copy of any policies** that have been put in place in your parish
3. providing a copy of your **latest risk assessment schedule and the latest Annual Return**
4. providing a report on the progress of any **outstanding items**

Risk Management Annual Return

On 30 November 2007, the **2007 Risk Management Annual Return** was sent for the parish to complete. The Annual Return covers both Modules 1 & 2 - please **get them in as soon as possible but no later than 15 April 2008**.

Over time we will be contacting parishes to **follow up the treatment plans** identified or risk areas not yet assessed. This will be particularly the case where there has been no progress made on **untreated risks identified in the 2006 return**.

Please note that **our Insurers** take an **active part in assisting parishes manage risk**, and on a regular basis undertake risk surveys throughout the Diocese.
