

## Proposal to reclassify the provisional parish of Minto as a parish

(A report from the Wollongong Regional Council.)

### Initiation of proposal

1. A proposal was made to the Archbishop by the Minister and Churchwardens of the provisional parish of Minto under clause 4(1)(b) of the Parishes Ordinance 1979.

### Details of Meeting

2. A meeting of the Wollongong Regional Council ("WRC") was held on 8 June 2004 to consider among other things the proposal under clause 5 of the Ordinance.

3. The WRC certifies that all procedural requirements under clauses 4 and 6 of the Ordinance have been complied with.

### Proposal

4. The proposal is to change the provisional parish to a parish.

### Parish Information

5. Minto provisional parish was created in 1978 having previously been part of the parish of Campbelltown. The Ministers since 1978 have been the Rev Peter Clifford (1978-1982), Rev Eric Bird (1982- 1989), Rev Graham McKay (1990-1998), Rev Robert Happer (2000-current). Minto itself is located in Campbelltown City Council area and services an area of both public and private housing. It is in the main a significantly disadvantaged area with many social problems.

6. The population of the area is relatively static although some redevelopment/rejuvenation programs are currently being undertaken by the Dept of Housing. Some surrounding areas are showing growth.

7. The total population within the parish stands at approximately 11,787. Around 24.2% (NCL) of the people within the parish continue to show some allegiance to the Anglican Church.

8. The area serviced by the parish is becoming quite diverse. Those of a NESB background are growing and there have been significant numbers of refugees settled in the area in recent times. The diversity of the parishioners includes a mix of people from South Africa, India, South Korea, Finland, East Germany, South America, Fiji, New Zealand, Bangladesh, United Kingdom, Indigenous and second, third & fourth generation Australians.

9. The provisional parish employs a Curate in Charge, the Rev Robert Happer and a part time Youth Worker Mr James Grady. There is also a parish run Op Shop employing a part time Manager. Many lay folk actively lead ministries in the parish.

10. There are 5 Primary Schools in the parish and 2 High Schools. SRE is taught in all the Primary Schools.

11. The provisional parish currently has 182 regular attendees. Average attendances are as follows:
