**MISCELLANEOUS AMENDMENTS ORDINANCE 1988**

No. 22, 1988

AN ORDINANCE to carry out certain law reforms.

WHEREAS it is expedient to clarify and update the terminology of certain ordinances.

NOW the Synod of the Diocese of Sydney HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:

**Accounts Ordinance**

1. The Accounts Ordinance 1975 is amended:—

- (a) by omitting from the definition of "parish" in clause 1, the words "provisional district" and by inserting "new housing district";
- (b) by omitting from the definition of "organisation" in clause 1, the words "Church of England" and by inserting instead the words "Anglican Church of Australia";
- (c) by omitting from subclause (3) of clause 1 the matter "-1978";
- (d) by omitting from clause 9 the matter "-1972";
- (e) by omitting the names of the organisations in the First Schedule and by inserting instead the following —

**Deaconesses, Readers and Other Lay Persons Ordinance 1981**

2. The Deaconesses, Readers and Other Lay Persons Ordinance 1981 is amended:—
  - (a) by omitting from parts (a) and (b) of the definition of "Minister" in subclause (1) of clause 1 the words "(as amended)";
  - (b) by omitting from the definition of "Church" in subclause (1) of clause 1 the words "Church of England in" and by inserting instead the words "Anglican Church of";
  - (c) by omitting from the definition of "church trust property" in subclause (1) of clause 1 the words "Church of England Trust Property Act," and by inserting instead the words "Anglican Church of Australia Trust Property Act";
  - (d) by omitting from clause 2, the figures "-1985".
