



## **New Sites Ordinance 1982 Amendment Ordinance 1999**

No 48, 1999

### **Long Title**

An Ordinance to amend the New Sites Ordinance 1982.

The Standing Committee of the Synod of the Diocese of Sydney Ordains as follows -

### **1. Name**

This Ordinance is the New Sites Ordinance 1982 Amendment Ordinance 1999.

### **2. Amendment of the Principal Ordinance**

The New Sites Ordinance 1982 is amended as follows -

(a) in clause 1(1) the definition of "Advisory Committee" is deleted and the following is inserted instead -

"Advisory Committee" means -

(a) the Bishop of Wollongong;

(b) the Bishop of Western Sydney;

(c) the Bishop of Liverpool;

(d) the Archdeacon of Wollongong;

(e) the Archdeacon of Western Sydney

(f) the Archdeacon of Liverpool; and

(g) if a bishop referred to in paragraph (a), (b) or (c) is also exercising the duties of archdeacon of the Region, the person appointed by that bishop;

(h) such other person or persons as the Standing Committee may appoint pursuant to clause 5.;"

(b) in clause 1(1) the following definition is inserted after the definition of "Board" -

"Vision 2001 Appeal" means the Vision 2001 Appeal endorsed or conducted by or on behalf of the Archbishop or such other appeal whose objects are the same as, or similar to, the Vision 2001 Appeal."; and

(c) in clause 1(1) the definition of "Assisted Provisional Parish" is deleted;

(d) clause 1(2)(a) is deleted and the following is inserted instead -

“(a) a recommendation is made by -

(i) either the Bishop of Wollongong or the Archdeacon of Wollongong; and

(ii) either the Bishop of Western Sydney or the Archdeacon of Western Sydney; and

(iii) either the Bishop of Liverpool or the Archdeacon of Liverpool; and

(iv) a majority of the persons appointed pursuant to clause 5, to the Property Trust, in writing, that the Property Trust acquire the same pursuant to clause 3; or”;

(e) after clause 4(6) and before clause 4(7) the following new clause is inserted -

“(6A) The proceeds of sale of any land which was acquired pursuant to this clause on or after 30 April 1999 shall be applied as follows -

(a) first, in the payment of all costs and expenses incurred in relation to the purchase, retention and sale of the land (or where such costs and expenses have been incurred in connection with the land and other land, an appropriate portion thereof), and the repayment of any sum borrowed on the security of the land; and

(b) the balance shall be paid to or at the direction of the Archbishop for the purposes of the Vision 2001 Appeal.”; and

(f) in clause 4(9) the following matter is inserted after the word “clause” in the second sentence -

“provided that where the land was acquired pursuant to this clause on or after 30 April 1999, such sum is to be paid to or at the direction of the Archbishop for the purposes of the Vision 2001 Appeal.”.
