
*Parramatta Anglican Regional Council Constitution
Amendment Ordinance 1981*

No. 40, 1981

AN ORDINANCE to amend the Parramatta Anglican Regional Council Constitution Ordinance 1971-1972.

WHEREAS by Resolution No. 29 of 1980 the Synod of the Diocese of Sydney agreed that the constituting ordinance of the Parramatta Anglican Regional Council should be revised NOW the Synod of the Diocese of Sydney HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:—

1. (1) This Ordinance may be cited as the "Parramatta Anglican Regional Council Constitution Amendment Ordinance 1981".
- (2) The Parramatta Anglican Regional Council Constitution Ordinance 1971-1972 is referred to in this Ordinance as the "Principal Ordinance".
2. The Principal Ordinance is amended:—
 - (a) by omitting paragraph (d) of clause 4;
 - (b) by omitting clause 8 and by inserting instead the following clause:—

"8. (1) Except as provided by subclause (2) of this clause, eight members of the Council of whom two at least shall be clergymen and two at least shall be lay persons shall form a quorum.

(2) For the purpose of exercising the functions conferred on it under the Delegation of Powers and Ordinance Procedure Ordinance 1973 (as amended), any three members of the Council shall form a quorum."
 - (c) (i) by omitting paragraphs (a) and (b) of clause 11 and by inserting instead the following paragraphs:—

"(a) to exercise the functions conferred on it under the Delegation of Powers and Ordinance Procedure Ordinance 1973 (as amended),

(b) to exercise the functions conferred on it under the Parishes Ordinance 1979."
 - (ii) by omitting paragraph (f) of clause 11;
 - (d) by omitting clauses 16, 17, 18 and 19 and the heading to clause 19 and by inserting instead the following heading and clause:—

"CITATION

16. This Ordinance may be cited as the "Parramatta Anglican Regional Council Constitution Ordinance 1971-1981".
3. The amendment made to the Sydney Church Ordinance 1912 (as amended) by clause 18 of the Principal Ordinance as in force immediately before the date of assent to this Ordinance shall continue to have the same force and effect as if that clause had not been repealed by this Ordinance.
