
Provincial Synod Constitution Amendment Ordinance 1970
No. 2 Adopting Ordinance 1970

No. 53, 1970

AN ORDINANCE for adopting a certain Ordinance of the Provincial Synod of N.S.W. entitled "Provincial Synod Constitution Amendment Ordinance 1970 No. 2".

WHEREAS a certain Ordinance entitled "Provincial Synod Constitution Amendment Ordinance 1970 No. 2" a copy of which is contained in the Schedule hereto was passed by the Synod of the Province of New South Wales on the 15th day of April, 1970 AND WHEREAS it is expedient that the said Ordinance should be adopted by the Church in this Diocese NOW the Synod of the Diocese of Sydney in pursuance of the powers in that behalf conferred upon it by the Constitutions for the management and good government of the Church of England in Australia within the State of New South Wales HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:—

1. The said Ordinance contained in the Schedule hereto is hereby adopted and so far as the same is applicable shall be applied to the management and good government of the Church in this Diocese.
2. This Ordinance may be cited as "Provincial Synod Constitution Amendment Ordinance 1970 No. 2 Adopting Ordinance 1970".

SCHEDULE

THE PROVINCIAL SYNOD CONSTITUTION AMENDMENT
ORDINANCE 1970, No. 2

AN ORDINANCE to authorise application to the Parliament of New South Wales to pass an Act providing for a certain part of the Constitution for the Provincial Synod of the Province of New South Wales to cease to have effect.

WHEREAS the Provincial Synod of the Province of New South Wales at a duly convened meeting held in the City of Sydney on the fifteenth day of April, 1970, considered it expedient, following the enactment of the Church of England in Australia Constitution Act 1961, to omit from the Constitution for the Provincial Synod of the Province of New South Wales Clause 9 thereof which provides that no rule, ordinance or determination of the Provincial Synod shall make any alteration in the Articles, Liturgy or formularies of the Church except in conformity with any alteration which may be made therein by any competent authority of the Church of England in England AND WHEREAS the said Provincial Synod also considered it expedient to promote in the Parliament of New South Wales a Bill to amend the said Constitution in the form set out in the Schedule hereto or to the like effect subject however to all the Dioceses in the Province of New South Wales assenting to this Provincial Ordinance by an Ordinance of its

Synod and General Synod ratifying the same WHEREFORE the Provincial Synod in the Province of New South Wales in pursuance of the powers in that behalf conferred upon it by the constitutions for the management and good government of the Church of England in Australia within the State of New South Wales and of all other powers thereunto enabling it ORDAINS PRESCRIBES AND RULES as follows:

1. Application shall be made to the Parliament of New South Wales by the Standing Committee of this Provincial Synod to pass an Act in terms of the Bill contained in the Schedule hereto or to the like effect provided that the Synod of every Diocese in the Province has accepted the same and General Synod has ratified by Canon the alteration to the said Constitution mentioned in the Schedule to the said Bill.
2. The said Standing Committee is hereby authorised and empowered to promote in the Parliament of New South Wales a Bill in terms of the said Bill in the Schedule hereto, or to the like effect, as soon as, and not before, the Metropolitan shall have reported to the said Standing Committee that the Synod of every Diocese in the Province has accepted this Ordinance and General Synod has ratified by Canon the said alterations and for the said purpose to confer and to act in conjunction with the Bishops and Chancellors of the Dioceses of the Province or any of them or any other person or persons and to do all such things and incur all such expense as may seem expedient in the circumstances.
3. This Ordinance may be cited as "Provincial Synod Constitution Amendment Ordinance 1970, No. 2".

SCHEDULE

A BILL to make provision with respect to the Constitution for the Provincial Synod of the Province of New South Wales; and for purposes connected therewith.

WHEREAS by an Ordinance duly passed by the Provincial Synod of the Province of New South Wales of the Church of England in Australia it was ordained and directed that application be made for the enactment of an Act in or to the effect of the provisions herein contained after the said provisions have been adopted by the Synod of the Diocese of each Province and after the General Synod of the Church of England in Australia has ratified and approved the said provisions BE it therefore enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:
