

**PROVINCIAL SYNOD - SYNOD REPRESENTATIVES ORDINANCE 1989  
ADOPTING ORDINANCE 1989**

No 31, 1989

**AN ORDINANCE to adopt a certain ordinance of the Provincial Synod.**

WHEREAS it is desirable to adopt the Synod Representatives Ordinance 1989, passed by the Provincial Synod on 28 February 1989.

NOW the Synod of the Diocese of Sydney HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows.

1. This Ordinance may be cited as the "Provincial Synod - Synod Representatives Ordinance 1989 Adopting Ordinance 1989".

2. The Synod Representatives Ordinance 1989, a copy of which is printed in the Schedule hereto, is hereby adopted.

**SCHEDULE**

AN ORDINANCE to amend the Schedule to the Anglican Church of Australia Constitution Act 1902 to confer certain powers on Diocesan Synods with respect to the election or appointment of representatives to those Synods.

WHEREAS it is expedient to enable the Synod of a Diocese within the Province of New South Wales to make ordinances with respect to the election or appointment of representatives to the Synod.

NOW the Provincial Synod of the Church in the Province of New South Wales pursuant to the powers conferred on it by Article 29 in the Schedule to the Anglican Church of Australia Constitution Act 1902 prescribes as follows.

**Citation**

1. This Ordinance may be cited as the "Synod Representatives Ordinance 1989".

**Amendment of Articles**

2. The articles and provisions of the constitutions contained in the Schedule to the Anglican Church of Australia Constitution Act 1902 are amended -

(aa) by omitting from Article 8 the words "And for electing" and by substituting the words "Subject to any other provision to be made by the Synod of a Diocese for electing";

(a) by omitting from Article 9 the words "The clergyman" and by inserting instead the words "Subject to any other provision to be made by the Synod of a Diocese, the clergyman";

(b) by omitting from Article 11 the words "In case" and by inserting instead the words "Subject to any other provision to be made by the Synod of a Diocese, in case";

(c) by omitting from Article 12 the words "The chairman" and by inserting instead the words "Subject to any other provision to be made by the Synod of a Diocese, the chairman"; and

(d) by inserting in Article 13 after the word "shall" the words "subject to any other provision to be made by the Synod of a Diocese".
