ORDINANCE. RANDWICK AMENDMENT. (As Passed.)

AN ORDINANCE to amend the "Saint Jude's Randwick Sale Ordinance of 1908" and to vary the trusts declared by the said Ordinance and for other purposes.

Whereas the land mentioned in "St. Jude's Randwick Sale Ordinance of 1908" has been sold and the net proceeds of sale have been invested in accordance with the provisions of the said Ordinance AND Whereas George Wall and William George Whiting two of the Trustees mentioned in the said nance are deceased and the present Trustees of the said proceeds of sale are the said Arthur Scott the remaining Trustee mentioned in the said Ordinance and Frederick George Crouch and William Crane Allpress who have been duly appointed in the places of the said deceased Trustees AND WHEREAS Saint Jude's

Rectory mentioned in the said Ordinance was built in or about the year One thousand eight hundred and seventy and no structural alterations were made thereto until recently AND WHEREAS it was recently necessary and expedient to remodel the said Rectory and to make additions and improvements thereto of a permanent character AND WHEREAS for the purposes aforesaid certain moneys were obtained upon a temporary loan pending application to Synod for permanent provision with regard to the cost of the said additions and improvements AND WHEREAS it is expedient that the cost of the said additions and improvements to an amount not exceeding Six hundred pounds should be provided for in manner hereinafter mentioned out of the said net proceeds of sale AND WHEREAS it is expedient to amend "Saint Jude's Randwick Sale Ordinance of 1908" for the purposes of authorising the Trustees for the time being of the said net proceeds of sale to apply a portion thereof not exceeding Six hundred pounds to the purposes aforesaid and of making provision for the matters hereinafter mentioned The Synod of the Diocese of Sydney in pursuance of the powers in that behalf conferred upon it by the constitutions for the management and good government of the Church of England within the State of Nw South Wales and of the powers vested in it by the "Church of England Trust Property Act 1917" or otherwise ordains directs and rules as follows: →

- 1. By reason of circumstances subsequent to the creation of the Trusts declared by "Saint Jude's Randwick Sale Ordinance of 1908" it has become inexpedient to carry out or observe in their entirety such Trusts.
- 2. The Trustees for the time being of the net proceeds of sale mentioned in the said Ordinance shall hold the same upon trust to apply a sum not exceeding Six hundred pounds in or towards discharging or recouping the cost of the additions and improvements made to Saint Jude's Rectory mentioned in the said Ordinance together with interest paid upon any moneys temporarily raised for the purposes of effecting the said additions and improvements.
- 3. The Trustees for the time being of the said proceeds of sale shall hold the remainder of the said proceeds of sale upon trust to pay the annual income in accordance with the provision of the said Ordinance to the Rector for the time being of Saint Jude's Randwick aforesaid.
- 4. "The Saint Jude's Randwick Sale Ordinance of 1908" shall be read as amended by this Ordinance.

5. This Ordinance may be cited as "Saint Jude's Randwick Amending Ordinance of 1919."
