
*Registry and Synod Assessments Amending
Ordinance 1939.*

No. 18, 1939.

AN ORDINANCE to amend "The Registry and Synod Assessments Ordinance of 1895."

WHEREAS by "The Registry and Synod Assessments Ordinance of 1895" (hereinafter called the Principal Ordinance) it was provided inter alia that prior to the First Session of each Synod the Standing Committee shall prepare a statement showing the sums to be annually contributed by each parish and district based on an assessment to be fixed in the manner provided in the said Ordinance.

AND WHEREAS the Principal Ordinance was amended by "The Registry and Synod Assessments Amendment Ordinance of 1896."

AND WHEREAS in accordance with the aforesaid Ordinances an assessment of £3238/18/8 per annum was fixed by the Synod in 1936 to operate from the first day of April 1937 to the thirty-first day of March 1940.

AND WHEREAS an adjustment was made by the Synod in the said assessment on the thirtieth day of August 1937 in the case of the Parish of Ashbury by reducing the same by the annual sum of £6/15/7.

AND WHEREAS the said assessment after such adjustment amounted to £3232/3/1 per annum.

AND WHEREAS by "The Registry and Synod Assessments Amending Ordinance 1937" it was provided inter alia that the said assessment should be increased as from the first day of April 1938 to the thirty-first day of March 1940 and such increase amounted to the sum of £538/13/9 per annum.

AND WHEREAS by the said lastmentioned Ordinance the Standing Committee was directed to make a thorough investigation of the finances endowments and trusts of the Diocese in order to determine whether and if so in what manner they can be used to better advantage for the work of the Church within the Diocese.

AND WHEREAS the said investigation has not yet been completed.

AND WHEREAS it is expedient to fix an assessment for a period of one year to take effect as from the first day of April 1940 to the thirty-first day of March 1941.
