
St. Aidan's Annandale Mortgage Ordinance 1957.

No. 54, 1957.

AN ORDINANCE to authorise an increase of the amount authorised to be borrowed by St. Aidan's Annandale Declaration of Trust and Mortgage Ordinance 1955; to amend the said Ordinance and for other purposes connected therewith.

WHEREAS since the passing of the St. Aidan's Annandale Declaration of Trust and Mortgage Ordinance 1955 it is expedient that the Parish Hall therein referred to should be further rebuilt in certain respects and for such purposes it is necessary and expedient to increase the amount thereby authorised to be borrowed.

Now the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod ordains and declares as follows:—

1. (a) This Ordinance may be cited as the "St. Aidan's Annandale Mortgage Ordinance 1957."
- (b) The St. Aidan's Annandale Declaration of Trust and Mortgage Ordinance 1955 is herein referred to as "the Principal Ordinance."
- (c) The Principal Ordinance as amended by this Ordinance may be cited as "The St. Aidan's Annandale Declaration of Trust and Mortgage Ordinance 1955-1957."

2. By reason of circumstances subsequent to the creation of the trusts to which the lands comprised in the Schedule to the Principal Ordinance are now subject, it is expedient to increase the amount authorised by the Principal Ordinance to be raised by Mortgage of the said lands to the sum of Three thousand five hundred pounds (£3,500) and to apply such increased amount for the purposes mentioned in the Principal Ordinance subject as herein provided.

3. Clause 3 of the Principal Ordinance is amended by adding the following new sub-clause:—

- 3 (iv) The Trustees are hereby empowered to increase the amount secured by the existing mortgage executed in pursuance of clause 3 (1) (a) hereof to the

sum of Three thousand five hundred pounds (£3,500) and to apply the additional sum borrowed for purposes set out in clause 4 (b) hereof subject to the payment of the costs charges and expenses of and incidental to the St. Aidan's Annandale Mortgage Ordinance 1957 and such mortgage and/or other security executed in pursuance of such Ordinance.

4. Sub-paragraph (1) (b) of clause 3 of the Principal Ordinance is amended by omitting the words and figures "three thousand pounds (£3,000)" and inserting in their stead the words and figures "three thousand five hundred pounds (£3,500)."
