
St. Andrew's Cathedral Site Ordinance 1972

No. 52, 1972

AN ORDINANCE to amend the St. Andrew's Cathedral Site Development Ordinance 1970.

WHEREAS Church of England Property Trust Diocese of Sydney is registered as the proprietor of the land comprised in Certificate of Title Volume 4804 Folio 186 and more particularly described in the First Schedule to the St. Andrew's Cathedral Site Development Ordinance 1970-1971 AND WHEREAS the said Ordinance authorised the subdivision of the said land and certain adjoining land into two lots therein and hereinafter defined as "Lot A" and "Lot B" respectively AND WHEREAS Lot B is held upon trust for all or any of the following purposes, that is to say, a site for a Cathedral Church, a residence for the Chief Officiating Minister of the Cathedral, a Church House and offices and otherwise in connection with the Cathedral and the administration of the affairs of the Church of England in the Diocese of Sydney AND WHEREAS Lot A is held upon the same trusts except to the extent (if any) that the said trusts have been varied by the said Ordinance and by the St. Andrew's Cathedral Site and Glebes Estates Variation of Trusts Ordinance 1971 AND WHEREAS it is expedient that the land comprised in Lot A and in Lot B be varied AND WHEREAS by reason of circumstances which have arisen since the creation of the trusts upon which Lot A and Lot B are held it is inexpedient to carry out and observe the same to the extent to which such trusts are hereby varied NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:—

1. (1) The St. Andrew's Cathedral Site Development Ordinance 1970-1971 is hereinafter referred to as the "Principal Ordinance".

(2) This Ordinance may be cited as the "St. Andrew's Cathedral Site Ordinance 1972".

(3) The Principal Ordinance as amended by this Ordinance may be cited as the "St. Andrew's Cathedral Site Development Ordinance 1970-1972".

2. In this Ordinance:—

- (a) the term "Lot A" has the meaning ascribed thereto in the Principal Ordinance,
- (b) the term "Lot B" has the meaning ascribed thereto in the Principal Ordinance,
- (c) the term "acquired land" has the meaning ascribed thereto in the Principal Ordinance,

(d) the term "Lot 1" means the lands described in the First Schedule hereto, and

(e) the term "Lot 2" means the land described in the Second Schedule hereto.

3. (1) By reason of circumstances which have arisen subsequent to the creation of the trusts in which Lot A and Lot B are held it is inexpedient to carry out and observe the same to the extent to which they are hereby varied.

(2) So much of Lot A and Lot B as is comprised in Lot 2 shall be held upon the same trusts as the trusts upon which Lot B was held immediately prior to the date on which this Ordinance was passed.

(3) So much of Lot A and Lot B as is not comprised in Lot 2 shall be held upon the same trusts as the trusts upon which Lot A was held immediately prior to the date on which this Ordinance was passed.

4. The Principal Ordinance and the St. Andrew's Cathedral Site and Glebes Estates Variation of Trusts Ordinance 1971 shall be read and construed, on and after the date on which this Ordinance is passed, as if:—

(a) any reference therein to Lot A is a reference to Lot 1 and the acquired land, and

(b) any reference therein to Lot B is a reference to Lot 2 and all rights powers and duties conferred upon the Standing Committee thereunder shall be limited to and apply in relation to Lot 1 and the acquired land.

FIRST SCHEDULE

ALL THAT piece or parcel of land situate in the City of Sydney, Parish of St. Andrew, County of Cumberland and State of New South Wales being Lot 1 of a subdivision of the land comprised in Certificate of Title Volume 4804 Folio 186: COMMENCING on the Western side of George Street at a point bearing 357 degrees 1 minute 76.805 metres from its intersection with the Northern side of Bathurst Street and bounded thence on the East by that side of George Street bearing 177 degrees 1 minute 23.205 metres: thence on the South, East and North-east by lines successively bearing 267 degrees 1 minute 70.35 metres, 177 degrees 1 minute 34.35 metres, 146 degrees 5 minutes 9.06 metres and 165 degrees 11 minutes 12.3 metres to the Northern side of Bathurst Street aforesaid; thence on the South and South-west by the Northern and north-eastern sides of that street bearing 266 degrees 11 minutes 18.605 metres, 266 degrees 34 minutes 40 seconds 35.14 metres and 283 degrees 30

minutes 3.41 metres to the North-eastern side of Kent Street; thence on the South-west by that side of that street bearing 344 degrees 29 minutes 20 seconds 71.33 metres to the North-western corner of the land comprised in Certificate of Title Volume 4804 Folio 186 and thence on the North-west by the North-western boundary of that land bearing 83 degrees 51 minutes 101.07 metres and 84 degrees 9 minutes 40 seconds 34.805 metres to the point of commencement having an area of 5761 square metres or thereabouts.

SECOND SCHEDULE

ALL THAT piece or parcel of land situate in the City of Sydney, Parish of St. Andrew, County of Cumberland and State of New South Wales being Lot 2 of a subdivision of the land comprised in Certificate of Title Volume 4804 Folio 186: COMMENCING at the intersection of the Western side of George Street with the Northern side of Bathurst Street and bounded thence on the South by that side of Bathurst Street bearing 266 degrees 30 minutes 63.17 metres; thence on the South-west, West and North by lines successively bearing 345 degrees 11 minutes 12.3 metres, 326 degrees 5 minutes 9.06 metres, 357 degrees 1 minute 34.36 metres and 87 degrees 1 minute 70.35 metres to the Western side of George Street aforesaid and thence on the East by that side of that street bearing 177 degrees 1 minute 53.6 metres to the point of commencement having an area of 3703 square metres or thereabouts.
