

ST ANNE'S RYDE (KIRKBY GARDENS) ORDINANCE 1968 AMENDMENT ORDINANCE 1991

No 8, 1991

AN ORDINANCE to amend certain provisions of the St Anne's Ryde (Kirkby Gardens) Ordinance 1968.

WHEREAS

A. Clause 8A of the St Anne's Ryde (Kirkby Gardens) Ordinance 1968-1980 (the "Principal Ordinance") provides for the provisions of Clause 8 of the Principal Ordinance to be reviewed as soon as reasonable possible after 31 December 1989.

B. The said review has taken place.

NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows.

1. This Ordinance may be cited as the "St Anne's Ryde (Kirkby Gardens) Ordinance 1968 Amendment Ordinance 1991".

2. Clause 8(ii)(b) of the Principal Ordinance is amended -

- (a) by the deletion of the words "the ordinances" and by the insertion of the words "an ordinance or ordinances"; and
- (b) by the deletion of the words "assented to hereafter and dealing with special purposes assessments".

3. Clause 8A of the Principal Ordinance is amended by the deletion of the figures "1989" and by the insertion of the figures "1991".

4. The Principal Ordinance is amended by the insertion of the following clause after clause 8A -

"8B. Notwithstanding the provision of clause 8(ii)(a) hereof the Corporate Trustee shall in the years commencing 1st January 1992 and 1st January 1993 deduct the sum of Sixty thousand dollars (\$60,000) per annum from the amount referred to in clause 8(ii)(a) hereof and pay such amount towards the reduction of a mortgage debt due to the Corporate Trustee by the churchwardens of the Church of St Stephen Thirlmere in the Parish of Picton in the Diocese of Sydney."

5. Clause 10 of the Principal Ordinance is amended by the deletion of the words "St Anne's Ryde (Kirkby Gardens) Ordinance 1968" and by the insertion of the words "Ryde (Kirkby Gardens, Archbold Building and 2 Little Church Street) Ordinance 1968".
