*"St. Catherine's Clergy Daughters' School Ordinance  
(Amendment) 1935."*

No. 4, 1935.

AN ORDINANCE to amend the St. Catherine's Clergy Daughters' School Ordinance 1922 and the St. Catherine's Clergy Daughters' School Ordinance (Amendment) 1931.

WHEREAS by the "St. Catherine's Clergy Daughters' School Endowment Ordinance of 1911" and the "St. Catherine's Clergy Daughters' School Ordinance 1922" and the "St. Catherine's Clergy Daughters' School Ordinance (Amendment) 1931" authority was given for the application out of the Endowment Fund of Three thousand two hundred and forty-six pounds five shillings (£3246/5/0) and such sum has been applied as directed.

AND WHEREAS the Sinking Fund formed to restore to the said Endowment Fund the amounts authorised to be applied as aforesaid amounted on the 19th March 1935 to the sum of £1526/12/8 AND WHEREAS on the 19th March 1935 the assets of the said Endowment Fund exclusive of the said sum of £3246/5/0 applied as aforesaid and of the said sum of £1526/12/8 the amount of the said Sinking Fund amounted to the sum of £3378/2/6. AND WHEREAS certain alterations additions and repairs are necessary to St. Catherine's Clergy Daughters' School and there are certain outstanding liabilities of the Council of the said School and it is expedient to authorise the said Council to appropriate a further sum of Two thousand pounds (£2000) out of the said Endowment Fund for such purposes aforesaid.

AND WHEREAS by reason of the hereinbefore recited facts it has become expedient to vary the trusts and directions contained in the hereinbefore recited Ordinances and the Declaration of Trust recited therein Now Therefore the Standing Committee of the Synod of the Diocese of Sydney in pursuance of the powers in that behalf conferred upon it by the Church of England Trust Property Act 1917 and the Land Ordinance Procedure and Delegation of Powers Ordinances and in pursuance of the powers vested in the said Synod by the Constitutions for the management and good government of the Church of England within the State of New South Wales or otherwise in place of the Synod directs declares and rules as follows:—

1. By reason of circumstances which have occurred since the creation of the hereinbefore recited Trusts it has become expedient to vary the Trusts.

2. Clause 18 of the said Ordinance of 1922 as amended by Clause 2 of the said Ordinance (Amendment) 1931 is hereby further amended by deleting the words and figures "Two thousand five hundred (£2500)" and inserting in lieu thereof "Four thousand five hundred (£4500)."

3. Clause 19 of the said Ordinance of 1922 as amended by Clause 3 of the said Ordinance (Amendment) 1931 is hereby further amended by deleting the words and figures "Three thousand two hundred and forty-six pounds five shillings (£3246/5/0)" and inserting in lieu thereof "Five thousand two hundred and forty-six pounds five shillings (£5246/5/0)."

4. Clause 20 of the said Ordinance of 1922 as amended by Clause 4 of the said Ordinance (Amendment) 1931 is hereby further amended by deleting the words "five years from the 1st July 1930" and inserting in lieu thereof "three years from 1st July 1935 and for such further period or periods as the Standing Committee of Synod may from time to time by resolution determine."

Provided however that this Clause as amended shall not come into operation until the 1st July 1935.

5. This Ordinance may be cited as the "St. Catherine's Clergy Daughters' School Ordinance (Amendment) 1935."
