AN ORDINANCE to amend Clause 5 of "St. Phillip's (Sydney) Church and School Resumption Ordinance 1934 Amendment Sale and Vesting Ordinance 1935." (No. 16, 1935)

WHEREAS by or under the provisions of the "St. Phillip's (Sydney) Church and School Resumption Ordinance 1934 Amendment Sale and Vesting Ordinance 1935" (hereinafter referred to as the Principal Ordinance) provision was made for the sale of the properties therein referred to and for the application of the proceeds arising therefrom. AND WHEREAS by or under the provisions of the "St. Phillip's Sydney Leasing and/or Mortgaging Ordinance 1939" the properties therein referred to being the properties referred to in the Principal Ordinance were authorised to be mortgaged. AND WHEREAS the said properties were mortgaged. AND WHEREAS the said properties have been sold and the mortgage discharged. AND WHEREAS by reason of circumstances subsequent to the creation of the trusts to which the purchase money arising from the sale of the properties are subject it is expedient to vary such trusts in manner herein-after mentioned and to make further provisions as hereinafter contained. NOW therefore the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod ordains and directs as follows:—

1. By reason of circumstances subsequent to the creation of the trusts to which the said purchase moneys are subject it has become inexpedient to carry out or observe such trusts insofar as the same are hereby varied.

2. Clause 5 of the Principal Ordinance is hereby amended by inserting after the words "in pursuance thereof" the following words "and the sum of One thousand two hundred and thirty-one pounds twelve shillings and eightpence (£1231/12/8) being the balance of the mortgage moneys interest and costs owing on the said properties as at the date of the said sale."

3. This Ordinance shall be deemed to have come into operation on the twenty-eighth day of August One thousand nine hundred and forty-four.

4. This Ordinance may be cited as the "St. Phillip's (Sydney) Church and School Resumption Ordinance 1934 Amendment Sale and Vesting Ordinance 1935 Amending Ordinance 1944."
