

ST. STEPHEN'S (NEWTOWN) LAY MISSIONARY FUND

VARIATION OF TRUST ORDINANCE 1985

NO. 5 1985

AN ORDINANCE to vary the trusts in respect of certain moneys and investments held in a Fund by the Trustees of a Fund know as "The St. Stephen's Lay Missionary Fund".

WHEREAS certain moneys and investments as particularised in the Schedule hereto are held by or under the control of the Trustees for the time being of a Fund known as the "St. Stephen's Lay Missionary Fund" (hereinafter called "the Fund") AND WHEREAS the Fund was originally established on 13th December 1981 and is 5 presently held inter alia as to corpus and income for the purpose of paying out of the income of the Fund a sum of up to \$260.00 per year to the lay missionary for the time being in the said parish for his own use and benefit AND WHEREAS by reason of 10 c : circumstances which have arisen since the creation of the trust upon which the Fund is held it is inexpedient to carry out and observe the same and it is expedient that the trusts accordingly be varied as hereinafter provided

NOW the Standing Committee of the Synod of the Diocese of Sydney in the place and name of the Synod HEREBY DECLARES RULES ORDAINS 15 AND DIRECTS AS FOLLOWS:-

1. By reason of circumstances which have arisen subsequent to the creation of the trust upon which the Fund is held it is inexpedient to carry out and observe the same and it is inexpedient to deal with or apply such fund or any part thereof 20 for the same or like purposes and it is expedient that the trust be now varied to the extent hereinafter set out.

2. The Fund shall be used paid or applied as follows:-

(a) To pay the costs of and incidental to the preparation of this Ordinance 25

(b) As to the balance of the Fund to be henceforth held by

the Churchwardens for the purpose of renovation, reconstruction, repair and maintenance of St. Stephen's Church Newtown the rectory, church buildings, and all other buildings fixtures and facilities of the said church. 30

3. This Ordinance may be cited as "St. Stephen's (Newtown) Lay Missionary Fund Variation of Trust Ordinance 1985".

SCHEDULE

The moneys and investments together with all interest accrued, known as the "St. Stephen's Lay Missionary Fund" and held by the Glebe Administration Board which at 28 February 1985 was \$7,159.19.
