

SYDNEY DIOCESAN SUPERANNUATION FUNDAMENDMENT ORDINANCE 1978

NO. 8 1978

AN ORDINANCE to amend the Sydney  
Diocesan Superannuation Fund  
Ordinance 1961-1977.

WHEREAS the Synod of the Diocese of Sydney by the Sydney Diocesan Superannuation Fund Ordinance 1961-1977 has established a Fund known as the Sydney Diocesan Superannuation Fund for the superannuation of clergy and certain other persons AND WHEREAS it is expedient to amend the provisions of that Ordinance NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:-

1. (1) The Sydney Diocesan Superannuation Fund Ordinance 1961-1977 is in this Ordinance referred to as the "Principal Ordinance".

(2) This Ordinance may be cited as "Sydney Diocesan Superannuation Fund Amendment Ordinance 1978".

(3) The Principal Ordinance as amended by this Ordinance may be cited as "Sydney Diocesan Superannuation Fund Ordinance 1961-1978", and in any reprint of that Ordinance clause 1 (1) shall be amended accordingly.

2. The Principal Ordinance is amended as follows:-

(a) by, in clause 2, following the definition of "Parish", inserting the following definition of parish sister reading as follows:-

"Parish sister means a parish sister appointed as such to serve in a fulltime capacity in a parish or in any department or organisation under the control of Synod other than schools";

(b) by deleting from clause 18 the phrase "other than in respect of deaconesses unless a request in writing to do so has been made to the Board";

(c) in clause 18 (a) (i) by adding the words "(2A) (2AB)" after the words and figures "sub-clauses (1) (2)" and by adding the

words "admitted under sub-clauses (1) (2) (2C) and (2D)  
of clause 19" after the word "member" where fifthly  
appearing;

30 by deleting the following words:-

"In the case of the member being a deaconess  
the additional amount \$C(65-X) as  
abovementioned shall not apply but should  
the Board have effected any insurance on  
35 the life of such deaconess at her request the  
proceeds of any such insurance shall be paid in  
addition to the amount held in the Fund for her  
credit;"

40 by deleting the word "other" where appearing in the last  
sentence;

(d) in clause 19, following sub-clause 2A, add sub-clause 2AB as  
follows:-

"(2AB) All parish sisters who are under the age  
of sixty years on 1 January 1978 shall become  
45 members on that date and every parish sister  
subsequently appointed or employed as aforesaid  
shall within three months become a member";

(e) in clause 19 (3) by adding the words "parish sisters" before  
the word "other" where first occurring, and adding the words  
50 "and parish sisters" after the word "deaconesses" where  
secondly occurring.

(f) in clause 20 (1) by inserting "(2AB)" between "(2A)" and "(2C)"  
and by deleting the word "or" and inserting the words "or  
parish sister" after the word "deaconess".

55 (g) in clause 20 (3) by inserting the words "or a parish sister"  
after the word "deaconess";

(h) in clause 23 by inserting the words "or parish sister" after the word "deaconess".

60 3. The provisions of clause 2 of this Ordinance shall operate from the first day of January 1978.
