

SYDNEY DIOCESAN SUPERANNUATION FUND ORDINANCE 1961-1981

AMENDING ORDINANCE (NO. 2) 1981

No. 53 1981

AN ORDINANCE to vary the provisions in the Sydney Diocesan Superannuation Fund Ordinance 1961-1980 relating to contributions.

WHEREAS:

It is expedient that the provisions of the Sydney Diocesan Superannuation Fund Ordinance 1961-1980 relating to contributions payable in respect of members of the Sydney Diocesan Superannuation Fund be varied.

NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod HEREBY DECLARES ORDAINS DIRECTS AND RULES as follows:-

1. (1) This ordinance may be cited as "Sydney Diocesan Superannuation Fund Ordinance 1961-1981 Amending Ordinance (No. 2) 1981."

(2) The Sydney Diocesan Superannuation Fund Ordinance 1961-1981 is herein referred to as the "Principal Ordinance".

(3) The Principal Ordinance as amended by this ordinance may be cited as "Sydney Diocesan Superannuation Fund Ordinance 1961-1981".

2. The Principal Ordinance is hereby amended as follows:-

(a) by the insertion of the matter "(a)" before the first word of Clause 24(1),

(b) by the insertion of the words "until the 31st of December, 1981" after the word "payable" where firstly appearing in Clause 24(1),

(c) by the substitution of the following for the words "and subject" in Clause 24(1)

(b) The annual contribution payable on and after the 1st of January, 1982 in respect of each ~~member becoming~~ person who is or becomes

a member under the provisions of sub-clauses (1), (2), (3), (4), (5), (6), and (7) of Clause 22 hereof shall be a sum equivalent to fifteen per cent (15%) of the minimum stipend for that member for the period in respect of which the contribution is payable and, for the purposes of this sub-clause, the minimum stipend shall be that determined by resolution of the Standing Committee.

- (c) Subject", and
- (d) by the insertion of the following after the word "hereof" where secondly appearing in Clause 24(1):-
 ", all contributions payable under this sub-clause (1)"
